CHECKLIST OF REQUIRED INFORMATION FOR FENCE PERMITS

The items listed below constitute a complete application for a fence permit. **Incomplete applications and plans that are code deficient require more review time, may be returned for corrections and delay the issuance of permits**

- A signed and completed Fence Permit Application form.
- A property site plan that is to scale and includes locations of all buildings, lot lines, public right-of-ways and the fence.
- A certificate of survey shall be required for all fences to be constructed up to or on the property line, UNLESS corner stakes are located and a survey exists in the property file
- A sketch or photocopy of the fence shall be submitted with this application.
